## **5. MARINA**

- 5.1. Use of the marina will be determined by the marina policy which is contained within this document and is supported by various signage throughout the property.
- 5.2. The marina policy may be amended by the Board of Directors from time to time.
- 5.3. The marina policy will not vary outside of any terms and conditions as prescribed by any governing body.

## **CAR PARKING POLICY**

1. All members and guests are required to park with consideration to the needs of fellow patrons.
2. Parking on the Marina Forecourt is to be considered a pick-up/drop-off or loading zone. There are limited spaces for all waterfront users and vehicles are not to be parked in this area for more than the sign posted time.
3. Parking on the Clubhouse level of the carpark, is limited to members and guests using the facilities. Anyone intending to stay on a boat or otherwise for the day (or longer) is required to park on the upper level.
4. Trailers and/or boats on trailers, other than those in designated trailer spots and leased dry-storage, are not permitted to be parked onsite without the prior consent of Management.
5. Access throughout the carpark and facility will be monitored by an access control system. The Board and Management may amend these controls from time to time.
  - a. Membership fobs/keyrings/cards are not transferrable.
6. Any member found to be acting in contradiction to this policy may be dealt with under the Constitution.

## **MARINA POLICY**

### 1. ACCESS

- a. Vehicular and Pedestrian Access to the marina is controlled by various control systems which are linked to membership accounts and is available to members with 24hr 'key access' through security gates. These keys are not transferrable and may be deactivated if found to be used inappropriately
- b. No vessel shall be allowed onto the marina that does not have current registration and insurance and that includes not less than \$10million in public liability cover.

### 2. SLIPWAY

- a. The slipway is licensed to a private business. This business will endeavour to service the needs of members of the RMYC Port Hacking as a priority when and where possible.
- b. The slipway is not authorised to conduct business before 8am or after 6pm.
- c. Access to the slipway is restricted to staff and contractors to the private business or the Club only. Anyone wishing to gain access to a boat on the slipway must not do so without the prior consent of the licensed operator or the Club.

### 3. BERTHING

- a. Long term berthing is available to Boat Owner, Veteran and Life Members of the RMYC Port Hacking only and the Berthing/Storage/Mooring Deed must be held in the name of the member, not a company.
- b. Berthing fees are charged by the length of the berth and fees are set by the Board of Directors and Management of the Club and may be amended from time to time.
- c. All berthing is subject to the terms and conditions as set out in the Berthing/Storage/Mooring Deed which is determined by the Board of Directors from time to time.
- d. Applications for berthing are to be made directly to management of the RMYC Port Hacking.
- e. All ropes, fendering and shore power leads must comply with the terms and conditions as set out in any Berthing/Storage/Mooring Deed.
- f. The Club has a number of swing moorings immediately south of the marina available for long term use by Boat Owner, Veteran &

Life members. The rates for these are determined by the Board and Management and may be amended from time to time.

- g. Long term berthing and mooring fees are payable in accordance with the Berthing/Storage/Mooring Deed.

## 4. CASUAL BERTHING

- a. Visitor, overnight or temporary berthing is available on a first come, first served basis and is at the discretion of management. Rates for casual berthing will be determined by the Board of Directors and Management and may be amended from time to time.
- b. Casual Berthing fees are payable immediately upon arrival.
- c. No member owing fees will be permitted to use the marina unless or until all prior accounts are paid in full.
- d. No vessel is to moor at the emergency section of the marina. This area is strictly for emergency use or use by the relevant authorities.
- e. No vessel is to moor at the boat ramp pontoon without prior permission from Management for any length of time other than that which is necessary in the act of vessel launching or retrieving.

## 5. CONTRACTORS

- a. No business may be conducted on or from the marina without consent from the Management of the Club.
- b. The marina is not a working marina or anchorage. Accordingly, only general engine servicing, minor repairs and/or maintenance may be carried out. No alterations, painting, hot works or any other servicing or maintenance that may result in pollution of the marina or cause nuisance or disturbance to other users of the facilities may be carried out under any circumstances.
- c. Contractors are not permitted to work on the marina before 7am or after 6pm without prior consent from management and must carry a marine card and adequate insurances.
- d. It is the members responsibility to ensure the contractor adheres to this policy when working on their vessel/s.

## 6. STAYING ABOARD

- a. Staying or living aboard your boat on the marina or a Club mooring is not permitted.
- b. Anyone wishing to stay aboard a boat overnight or for any period longer than 24 hours must have prior permission from Management.

- c. No person may stay aboard for more than 7 nights in any calendar month without written permission from the Club.

## 7. BOAT RAMP

- a. The boat ramp is not available for the launching or retrieval of boats before 7am or after 10pm.
- b. Boats must be winched onto trailers and are not to be driven onto trailers under any circumstances. Powering your boat in the boat ramp area may cause disturbance, undermining of the ramp and sediment deposit onto the slipway rails which could derail the cradles.

## 8. FUEL

- a. Refuelling is not permitted on the marina. The Club has a Boating Member discount arrangement with Burraneer Bay Marina for 25c/litre off fuel. Details can be found on the Club's website at [www.rmycph.com.au](http://www.rmycph.com.au). To be eligible for this discount you must complete the fuel discount form on our website here - <https://rmycph.com.au/burraneer-bay-marina-fuel-promotion/>

## 9. TENDER/DINGHIES

- a. The tender is available for use by all Boat Owner, Veteran, Life and Crew members.
- b. The tender is skippered on weekends and public holidays by the marina assistant staff. Outside of these days the tender keys are available at the bar on a self-drive basis.
  - i. *Self-Drive - The tender is to be used with consideration to the needs of all members. If you intend to be out for any length of time prior consent is required and you must make yourself available by phone should anyone else require the use of the tender.*
- c. There are a number of dinghies available at the marina. These are to be returned to or picked up from the marina and must not be left on moorings.

## 10. SWING MOORINGS

- a. The Club has a number of swing moorings situated throughout Port Hacking at Jibbon, Darke Bay and Gooseberry Bay as well as one at Frenchman's Bay LaPerouse. These moorings are for RMYCPH members only and should be used with consideration to all members.

- b. The Club also has a number of moorings situated in South West Arm. These are for general public use. RMYCPH members may raft up with anyone using these moorings.

### 11. GENERAL

- a. In the event that a vessel is owned by more than one person;
  - i. all owners must become Boating Members in order to use the facilities; and
  - ii. any agreement relating to that vessel shall be joint and several and any communication to or from the Club in relation to that vessel shall be deemed to be to or from all owners.
- b. The Club may from time to time be required to move a vessel on the marina or swing mooring in order to perform maintenance or repair work or to afford berthing of another vessel.
- c. Fishing is not permitted from or within the marina without prior consent from management.
- d. Pets must be on a leash and in the control of their owner when on the marina and are only permitted to pass through the Club grounds to gain access to or from the marina.
- e. Children are not permitted on the marina or marina forecourt parking area unless in the immediate company of a responsible adult.
- f. The consumption of alcohol is not permitted on the marina walkways or fingers at any time.
